

STATEMENT OF CONFIDENTIALITY

Adamant Finance Limited.

The Company “Adamant Finance Limited” sincerely recognizes the right of all our clients for confidentiality. Protection of personal and financial data of our clients and website visitors is our top priority. This statement of confidentiality describes how the company “Adamant Finance Limited” collects and subsequently stores, and protects your personal information.

DATA COLLECTION

Visitor (s) of the official web site of “Adamant Finance Limited” usually do not provide information about themselves. However, there are cases when we request personal data of a user, when you open or maintain a real or demonstration trading account, for commercial purposes, such as evaluation of your financial needs, processing of your requests and transactions, to inform you promptly about new products and new kinds of services, and to provide you with timely technical support. Information obtained directly from you includes data required to communicate with you, and it includes your name, postal address, telephone number, place of residence and e-mail address.

USE OF PERSONAL DATA

Information obtained from you can be used by “Adamant Finance Limited” in order for verification of your identity and further cooperation. This information can be used by us for registration and further administration of a trading account, selection of a unique number and secure password, maintenance of the account and communication with you regarding the status of your trading account. This information allows us to improve the quality of services, be fast in reporting about new products, services and offers that may be of interest to you.

In case of account closure, “Adamant Finance Limited” keeps information about you secret except for cases when disclosure is required in accordance with regulatory requirements, and when it use it to contact you from time to time to inform you about the possibility to re-open your account and take advantage of attractive offers.

CHANGES TO THE STATEMENT OF CONFIDENTIALITY AND WEBSITE SUPPORT

With the growth and rapid development of this business, as well as changing of technologies in Internet industry, “Adamant Finance Limited” may from time to time modify, improve their policy, including confidentiality policy. All changes will be published on the official website of

the company, so you should regularly review this confidentiality policy, applications and other documents published on the company's website.

On our part, we state that the company "Adamant Finance Limited" will not sell or distribute your personal data.

A user is not obliged to provide us any personal data that we might need, but your refusal to provide personal information necessary, which is for us, might be the reason why we will not be able to provide you all services for our company entirely, such as opening of a trading account and its technical support.

SECURITY OF YOUR PERSONAL INFORMATION

We use reliable software, systems and procedures to create a safe and proven trading environment, and to protect your personal, financial and trading data. When opening an account with us, you obtain a unique account number, user ID and a password. Only a limited number of employees of "Adamant Finance Limited", who need to know this information, will have access to your account number, your user identifier and your password. Please remember: you are responsible for the security of your account number, your user identifier and password. We strongly recommend that you do not disclose this information to anyone else.

TRANSFER OF DATA TO PARTNERS

We may share the abovementioned personal information with our partners to use it for business purpose, such as maintenance of clients' accounts and informing about new products and services in accordance with the relevant rules. Our partners may be the companies owned or run by us. Information, which can be conveyed to our partners, may include information described above. Our partners adhere to confidentiality rules with regard to your information to the same extent as "Adamant Finance Limited" according to this confidentiality policy.

USE OF COOKIES

We use cookies in order to enhance the security of your trade operations and improve the performance of our website. (Cookies are small text files sent to your computer from a web server.) Cookies used by "Adamant Finance Limited" do not contain personal information, nor account or password data. With their help, the company's website can determine that a request to view the page comes from a person who has already performed the entry.

"Adamant Finance Limited" may disclose information about the use of the website to advertising companies having a reliable reputation in order to increase the effectiveness of our advertisement on this and other websites. In order to mark viewed pages, so-called "pixel tags" (also known as "clear gifs" or "web beacons") are used. Information gathered by advertising companies with the help of "pixel tags" does not enable to establish identity.

For management and improvement of the website, we may engage third parties to follow-up and analyze statistical information concerning the website use, including a number of page requests, request form and the access path. Third parties may use cookies to monitor the behavior and may appoint cookies on behalf of the company. These cookies do not contain any personal data.
